Notice is hereby given that pursuant to Folly Beach Code of Ordinance, Section 31-50 through 31-54, a general election will be held in the City of Folly Beach, South Carolina on Tuesday, April 6, 2010 to fill the expired terms of three (3) council persons and one (1) mayor of the City of Folly Beach.

Any candidate to be eligible to have his/her name on the ballot must file a Statement of Candidacy; pay \$50 filing fee for the mayor's seat or a \$25 filing fee for council seat to the Municipal Clerk or a Municipal Election Commissioner before noon of the last day to file. **The last day to file is Tuesday, February 2, 2010 at 12:00 noon.** Filing Packets for candidates may be picked up at the Municipal Clerk's Office, 2nd Floor, Folly Beach City Hall, 21 Center Street, Folly Beach, South Carolina on or after Friday, **January 19, 2010.**

This election shall be at-large, non-partisan, and by majority vote as determined by South Carolina Code 5-15-62.
