The Charleston County Commission on Management, Accountability and Performance (MAP) is conducting a Citizen Public Opinion Survey.

The closest look in decades at how county government operates is under way in Charleston County. Modeled after Governor Mark Sanford's Commission on Management, Accountability and Performance, the bipartisan and independent Charleston County MAP Commission was formed earlier this year by a unanimous vote of County Council. Thirteen commissioners, plus dozens of task force members from the business community and governments, are working together examining the way Charleston County does business. The end result will be a series of recommendations on ways to reduce costs and duplication, increase efficiency and accountability, and improve productivity and delivery of services.

To fulfill its purpose, the MAP Commission NEEDS YOUR HELP! Through a county-wide survey of residents and businesses, the Commission is soliciting input on customer satisfaction with services provided, and public perceptions of the county and its government.

Total 861 comments subjectively moved into categories as follows:

- 1. Comments are organized by task force, plus grouped into most frequently addressed topics.
- 2. There are three pages of tax comments, all sorted into the Budget/Finance Task Force.
- 3. There are three pages of Transportation Task Force related comments, most dealing with CARTA, traffic and roads.
- 4. A category was created for Solid Waste; litter and recycling comments are most common here.
- 5. Many comments deal with specific services or departments. An 'Other County Departments, Services' category was created for these.
- 6. There is a category for school/education comments.
- 7. The largest category, by far generating more comments than any other, is 'Growth/Planning/Land Use.' Over six pages of comments suggest this topic resonates most loudly with Charleston residents.
- 8. 'Citizen Services' was created for generic service-related comments.
- 9. A sizable number of comments are related to social services; a category was created for those.
- 10. Finally, 'General Government' is a miscellany category.
- 11. All comments appear as written. No attempt has been made to correct spelling, punctuation, or grammar, or to alter the sentiment.

Push for annexation of unincorporated areas into town areas.


Council members should represent interests of their constituents.
