<b>1</b>	<b>Infrastructure: Sidewalks, water, and sewer</b>	Water/Sewer—Serve <b>473 households</b> by providing access to water services or an upgrade to a household’s well &/or septic system. Install <b>2,120 linear feet</b> of sidewalk.
<b>2</b>	<b>Rehabilitation and Preservation for substandard housing</b>	Provide emergency rehabilitation assistance to <b>60 households</b> . Provide housing rehabilitation to <b>50 units</b> .
<b>3</b>	<b>Affordable Housing: Construction, down payment assistance and reconstruction</b>	Provide <b>ten (10) affordable housing units</b> and down payment assistance for <b>10 households</b> .
<b>4</b>	<b>Public Services: Social service activities, education, training, and prevention</b>	Serve <b>40,000 households and/or individuals</b> via services related to education, training, and prevention.
<b>5</b>	<b>Special Economic Development: Business incubators, small business development start-up funding</b>	0
<b>6</b>	<b>Demolition and Clearance: To prevent/alleviate slum and blight</b>	0
<b>7</b>	<b>Historic Preservation: The preservation of historic buildings for community use</b>	0

RANKING	PRIORITIES	GOALS AND OUTCOMES
1	<b>Shelter Operations:</b> Food, utilities, staff	Support homeless shelter costs related to operations staff and utility costs by awarding ten <b>(10) shelter operation projects.</b>
2	<b>Essential Homeless Services:</b> Counseling, employment, case management, housing assistance	Serve <b>300 homeless individuals</b> through counseling, employment services, case management, and/or housing assistance programs.
3	<b>Renovation:</b> To create shelter space or to increase bed capacity	Increase homeless shelter bed count by <b>25 beds.</b>
4	<b>Homeless Prevention Activities:</b> services provided to those at-risk of becoming homeless such as: emergency mortgage, rental or utility payment, food, etc.	Serve <b>2,500 individuals</b> who are at-risk of becoming homeless through projects relating to emergency mortgage, rental or utility payments, the provision of food, or assisting with medical expenses.

2	<b>Conversion:</b> Converting existing structures into affordable housing	<ul style="list-style-type: none"> <li>• <b>Amend County ordinance(s)</b> to alter density requirements when affordable housing will result.</li> <li>• Work to enact <b>form-based zoning</b> regulations for in-fill projects.</li> <li>• Create and complete a <b>county-wide affordable housing plan</b> to address issue such as high density nodes; locations; complementary ordinances; and issues related to taxation and fees.</li> </ul>
3	<b>Homebuyer Activities:</b> Home occupancy/ training/counseling and/or down payment assistance	Provide training, counseling and/or down payment assistance programs that result in homeownership for <b>20 households</b> .
