Chairman Summey thanked Mr. Darby for starting this important recognition program several years ago. Mr. Darby thanked Council for participating in this recognition and stated that we don't have to look nationally for heroes. There are heroes in Charleston doing good work every day.

Chairman Summey asked Deputy Administrator for Finance Keith Bustraan to assist in recognizing the Budget Department. Mr. Bustraan recognized Budget Director Mack

Gile and Assistant Director LoElla Smalls and stated that Charleston County Government's Budget Office recently received the Distinguished Budget Presentation Award for its fiscal year 2015 budget from the Government Finance Officers Association of the United States and Canada (GFOA). According to the GFOA, the award reflects the commitment of Charleston County Government and its staff to meeting the highest principles of governmental budgeting. The award is for the fiscal year 2015, which runs from July 1, 2014 through June 30, 2015. The award was given based not only on how well the County budgets its funds, but also on how well it communicates to the public how the money is spent. The County develops a Citizen's Guide to the budget each year so that residents can easily see where their tax dollars are going. The fiscal year 2015 budget was judged and awarded by financial peers from government organizations around the country, marking the 26th consecutive year that Charleston County government's Budget Office has won the honor. GFOA is a non-profit professional association serving 16,000 government finance professionals throughout North America. The GFOA's Distinguished Budget Presentation Awards Program is the only national awards program in governmental budgeting.

Chairman Summey asked County Administrator Kurt Taylor to assist in recognizing Coroner Rae Wooten and the Coroner's Office. Mr. Taylor stated that the International Association of Coroners and Medical Examiners recently announced that the Charleston County Coroner's Office received accreditation by the association. The Charleston County Coroner's Office self-submitted to this process for the purpose of ensuring the operating policies, procedures and practices are within international guidelines. The Charleston County Coroner's Office was subjected to review of 288 standards including administrative, forensic, investigative and facility review. The IAC&ME requires 100% compliance of mandatory standards and 90% of all applicable standards. The IAC&ME extends its compliments to Charleston County for submitting to this level of review and stated that when an agency elects to subject themselves to this process it clearly indicates their desire to stand to peer review and demonstrates to the public and stakeholders a strong desire to provide excellence in service provision. The completion of this process, which is for five years, indicates a professionalism and compassion by the Charleston County Coroner's Office.

Charleston County Council congratulated the Charleston County Coroner's Office and Coroner Rae Wooten, for the diligence in complying with these standards leading the way in service and compassion for those they serve and their community and presented the Coroner with a County Seal lapel pin.

It was stated that Charleston Center is requesting authorization to accept an award for \$100,000.00; this award will be used for building sustainable professional development infrastructure and staff retention through enhanced collaborative relationships with the Department of Mental Health and through the provision of high-end training and implementation science initiatives.

It was stated that Charleston County Transportation Development Department has sought bids for Microsurfacing of various paved roadways within the boundaries of Charleston County. The work shall include

traffic control, surface preparation, asphalt Microsurfacing, striping and other incidental construction. The total project length is approximately 13.58 miles.

Charleston County Transportation Development has worked diligently for many years to identify innovative ways to maintain the road network. Microsurfacing is one of the innovative tools that can be used to preserve a road that is currently in good condition at a cost that is significantly lower than a full rehabilitation or reconstruction of a roadway. It is a cold mixed asphalt mixture consisting of fine aggregate, asphalt and other additives that is proportioned to seal aged raveled pavement. The seal protects the existing pavement surface from water, sun UV rays and traffic wear. By sealing our roads with Microsurfacing and other preservation treatments while they are in good condition extends the life of the pavement and provides for a better service life to the citizens while reducing the life cycle cost of maintaining our road network.

In 2010/2011 Charleston County Transportation Development successfully completed the first Microsurfacing contract as a pilot project and subsequently in 2013 we partnered with SCDOT on a \$1 for \$1 match program to successfully complete the largest Microsurfacing contract in the state to date.

Bids were received in accordance with the terms and conditions of Invitation for Bid No. 4921-15C. The mandatory Small Business Enterprise (SBE) utilization for this solicitation is 12.2% and the Disadvantaged Business Enterprise (DBE) goal is 20%.
