Traffic Alert: Feb. 24 Nighttime Lane Closure on Folly Road Blvd.

Lane closure for U.S 17/S.C. 61/Wesley Drive Improvements Project in West Ashley

<u>Charleston County Government</u> announces a traffic alert as part of the <u>U.S.17/S.C.61/Wesley</u> <u>Drive Improvements Project</u> in West Ashley that will affect Folly Road Boulevard as follows:

- A lane closure will occur for work on driveways on Folly Road Boulevard for one night on Thursday, Feb. 24 from 9 p.m. - 6 a.m.
- The far right, northeast-bound lane of Folly Road Boulevard (heading from the Wapoo Cut bridge toward Downtown/Ashley River bridge) will be closed from Windermere Boulevard to Albemarle Road.
- The adjacent, northeast-bound lane of traffic will remain open while construction crews work on Folly Road Boulevard.
- At no point will the entire roadway be blocked to traffic.
- If the weather is poor on the evening of Feb. 24, the closure will occur at the same time on Monday, Feb. 28.

Drivers traveling through the project area are asked to be aware of equipment and crews working in the area. Alternative routes are recommended if possible during the closure. The public is also asked to notice traffic control signs, reductions in speed limit and message board information, and to note that all road work is dependent on the weather.

BACKGROUND ON THE PROJECT:

- Construction on the project began in January 2011. The goal of the project is to improve traffic flow, drainage, and pedestrian and bicyclist mobility.
- The project, which is expected to be completed in May of 2011, is funded by the
 <u>Charleston County Transportation Sales Tax</u> and managed by <u>Charleston County</u>
 <u>Government</u>'s RoadWise Program, in close coordination with the <u>City of Charleston</u> and the <u>S.C. Department of Transportation</u>.
- The U.S. 17/S.C. 61/Wesley Drive Improvements Project includes improvements to Folly Road from south of Windermere Boulevard (Wappoo Bridge side) starting at Yeamans Road and continuing up Wesley Drive to St. Andrews Boulevard (S.C. 61).
- The project also includes improvements to Folly Road Boulevard from Windermere Boulevard up to Albemarle Road.
- Every effort is being made to schedule necessary lane closures for the project during offpeak, nighttime and weekend hours when possible to minimize effects on traffic.
- Some lane closures may be scheduled during the day on selected weekends.
- Advance notice of all lane closures will be provided to the media.

- The U.S.17/S.C.61/Wesley Drive project was requested by the <u>City of Charleston</u> and approved by voters in <u>the first bond referendum</u>. The voters of Charleston County authorized the County to issue \$77 million in bonds, which will be repaid through Transportation Sales Tax revenues. The entire amount of the first bond referendum is allocated for the following transportation improvement projects:
 - o Folly Road and Maybank Highway Intersection Improvements
 - o Glenn McConnell Parkway / Bees Ferry Road Intersection (West Ashley Circle)
 - o Harbor View Road Improvements
 - o U.S. 17/S.C. 61/Wesley Drive Improvements
 - o Palmetto Commerce Parkway
 - o US 17 / Johnnie Dodds Boulevard Improvements
