This is a nonpartisan, at large, municipal election conducted pursuant to SC Code of Laws § 5-15-62, nonpartisan and runoff method of election. No party affiliation shall be placed on the ballot.

Any Runoff Election will be held on Tuesday, November 16, 2021 at the precincts listed below.
