Three (3) Council seats to be filled Terms Expire June 30, 2025

Notice is hereby given that the Municipal Election Commission for the Town of Hollywood, in conjunction with the Board of Elections and Voter Registration of Charleston County, will conduct the Town of Hollywood Municipal Election for three (3) seats on the board of Town Council at the voting precincts fixed by law on June1, 2021.

The last day that persons may register to be eligible to vote in this election is April 30, 2021. If submitting a registration application by mail or fax, it must be post marked no later than May 1, 2021.

Citizens desiring to be candidates for one of the above listed seats may file their Statement of Intention of Candidacy at Hollywood Town Hall; 5150 HWY 165, Hollywood, SC 29449. Books will be open from March 19, 2021 to April 1, 2021 during regular business hours; between 8:00am until 5:00pm. The filing fee for seat of Council is \$35. This is a non-partisan election and no party affiliation will be placed upon the ballot.

The office will be closed for Holiday observance on April 2, 2021.

The polls will be open from 7:00am until 7:00pm at the locations designated below. The Managers of election see that each person offering to vote takes the oath that he/she is qualified to vote at this election according to the Constitution of this State and that he/she has not voted before in this election.

Voters who are blind, physically handicapped, or unable to read or write are entitled to assistance in casting their ballot. This assistance may be provided by anyone the voter chooses except their employer, an agent of their employer, or an officer/agent of their union. The Clerks must be notified if assistance is needed. Voters who are unable to enter their polling place due to physical handicap or age may vote in the vehicle which they drove, or were driven in, to the polls. When notified, the Managers will help voters using this curbside voting provision.

Registered electors who cannot vote in person may be eligible to vote by absentee voting; they should contact the Board of Elections and Voter Registration Office of Charleston County at 843-744-8683.

At 9 A.M, the day before Election Day, the Board of Elections and Voter Registration Office of Charleston County will begin its examination of absentee ballot returned envelopes at 4367 Headquarters Road, North Charleston, SC 29405. A Public Hearing to consider provisional ballots will be held at 12:00Noon, on Thursday, June 3, 2021 at Hollywood Town Hall.
