

**NOTICE OF GENERAL ELECTION
TOWN OF ROCKVILLE, SC - Update
NOVEMBER 2, 2021**

Notice is hereby given that the Charleston County Board of Elections and Voter Registration will conduct a General Election for the Town of Rockville on Tuesday, November 2, 2021 to fill (1) seat for the office of Mayor, and (4) four Town Council seats.

This is a nonpartisan, at-large, municipal election, and no party affiliation shall be placed on the ballot. **Term of office will expire December 2025.**

Candidate filing opens 12:00 noon on Monday, August 16, 2021 and filing closes 12:00 noon on Friday, August 27, 2021. **There are no filing fees for the office of Mayor or Town Council.**

A Statement of Economic Interest form must be filed electronically (on-line) at <http://ethics.sc.gov> prior to filing a Statement of Candidacy and or Petition. Those requiring electronic filing assistance may contact the South Carolina State Ethics Commission at 803-253-4192.

Residents desiring to file as a candidate for the Office of Mayor or Town Council must file a Statement of Candidacy with the Charleston County Board of Elections and Voter Registration, 4367 Headquarters Rd, North Charleston SC. Office business hours are Monday – Friday, 8:30 am to 5:00 pm. You may obtain additional information by calling the elections office at 843-744-8683.

The last day that persons may register to be eligible to vote in this election (In Person) is October 1, 2021. (Online deadline is Sunday, October 3, 2021). If submitting a voter registration application by mail or fax, it must be post marked no later than Monday, October 4, 2021.

Registered voters who cannot vote in person may be eligible to vote by absentee ballot. Absentee ballots may be obtained from the Charleston County Board of Elections and Voter Registration. You may call 744-8683 or send an email to absentee@charlestoncounty.org to inquire about the availability of absentee ballots.

At 9:00 a.m., on Monday, November 1, 2021 the Charleston County Board of Elections and Voter Registration will begin the examination of the absentee ballot return envelopes. This process will take place at the Board of Elections office, 4367 Headquarters Road, North Charleston, SC.

On Thursday, November 4, 2021 at **10:00 A.M.**, the **Municipal Election Commission** will hold a public hearing at the Rockville Presbyterian Church, 2479 Sea Island Yacht Club, Rockville SC to determine validity of all ballots challenged in this election and certify election results.

Any Runoff Election will be held on Tuesday, November 16, 2021 at the precinct listed below.

This Municipal Election will be held under new rules for providing Photo ID at the polling place. The polls will open from 7:00 a.m. until 7:00 p.m. at the polling places fixed by law in this county:
