Notice is hereby given that the Charleston County Board of Elections and Voter Registration will conduct the Special Election for the City of Folly Beach on Tuesday, April 23, 2024. Any person wishing to vote in this election must register no later than Sunday, March 24, 2024. Voter registration by mail forms will be accepted if postmarked by Monday, March 25, 2024. If necessary, a runoff will occur on May 7, 2024.

Candidate Filing

Candidate filing opens at 12:00 p.m. on Friday, January 26, 2024 and filing closes at 12:00 p.m. on Monday, February 05, 2024. The offices, fees, and requirements are listed below.

A hearing will be held to determine the validity of all provisional ballots cast in this election by the County Board of Canvassers at 10:00 a.m. on Thursday, April 25, 2024. This hearing will take place at the Charleston County Board of Voter Registration office at 4340 Corporate Rd., North Charleston, SC 29405. If necessary, the runoff hearing will be at 10:00 a.m. on Thursday, May 9, 2024.
