Notice is hereby given that the Charleston County Board of Voter Registration and Elections will conduct the Special Town Council Election for the Town of Lincolnton on Tuesday, June 11, 2024. Any person wishing to vote in this election must register no later than Sunday, May 12, 2024. Voter registration by mail forms will be accepted if postmarked by Monday, May 13, 2024. If necessary, a runoff election will occur on Tuesday, June 25, 2024.
