

PUBLIC NOTICE OF SPECIAL ELECTION

STATE OF SOUTH CAROLINA

COUNTY OF CHARLESTON

A Special Election for School Board of Trustees District 6 will be held on Tuesday, February 7, 2023. Any person wishing to vote in this special election must be registered no later than Sunday, January 8, 2023. Voter registration by mail forms will be accepted if postmarked by Monday, January 9, 2023.

A special candidate filing period begins at noon, December 2, 2022, and concludes noon, December 12, 2022. Any candidate seeking this office must file during this period at the Charleston County Board of Elections and Voter Registration at 4367 Headquarters Rd. North Charleston, SC 29405. The hours are Monday-Friday between 8:30 a.m.--5:00 p.m. There is no filing fee.

The early voting period for this election begins on Monday, January 23, 2023, and ends on Friday, February 3, 2023. The following early voting center will be open during the early voting period from 8:30 a.m.--5:00 p.m., Monday through Friday:

Voters will be asked to provide one of the following Photo IDs when voting in person:

- S.C. Driver's License
 - Includes standard License and REAL ID
- S.C. Department of Motor Vehicles ID Card
 - Includes standard ID card and REAL ID
 - Includes SC Concealed Weapons Permit
- S.C Voter Registration Card with Photo
- Federal Military ID
 - Includes all Department of Defense Photo IDs and Veterans Affairs Benefits Card
- U.S. Passport
 - Includes US Passport ID Card

If you have one of these Photo IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false. At 9:00 a.m. on the day before the special election, the Charleston County Board of Voter Registration and Elections will begin its examination of the absentee ballot return envelopes at 4367 Headquarters Rd. North Charleston, SC 29405.

On Thursday, February 9, 2023, at 10:00 a.m. the County Board of Canvassers will hold a hearing to determine the validity of all provisional ballots cast in the special election. This hearing will be held at 4367 Headquarters Rd. North Charleston, SC 29405.
