The calculation of annualized compensation takes the established hourly rate and estimates what the annual compensation will be based on the estimated number of regularly scheduled hours of work, which is subject to change based in scheduling.

REMEMBER: If exempt, the annualized compensation more closely estimates your pay. If non-exempt, the hourly rates reflects the true rate of pay, and the annualized compensation should be used as a refernece only.
