#### **HOME Investment Partnership Program**



### A total of 6 affordable dwelling units were added during PY2021:

- 3 new construction units for homeownership
- 1 rehabilitated unit for homeownership
- 2 rehabilitated units for rental

#### Community Development Block Grant

- 21 LMI households provided with access to clean water and/or sanitary sewer
- 3 Condemned structures demolished in the City of North Charleston
- Public services provided to 1,385 individuals
- 72 Persons provided with overnight shelter
- Emergency housing repairs for 53 LMI households



#### **Emergency Solutions Grant**

- Rapid rehousing provided to 6 families experiencing housing insecurity
  - Overnight shelter provided to 84 individuals experiencing homelessness

Emergency Rental Assistance Program\*

- \$31 million in rental assistance
- \$1.8 million in utility assistance
- 4,130 tenants supported
- 772 landlords served
