Public Safety Committee Chairman Elliott Summey has called a Public Safety Committee meeting on December 6, 2018 to allow Charleston County Consolidated 9-1-1 Center Director Jim Lake to make a presentation on the following:

- Proposed new South Carolina 9-1-1 Legislation
 - This will allow for statewide development of "Next Generation 9-1-1" and standardization of 9-1-1 infrastructure throughout SC
- Consolidated 9-1-1 Center efforts toward a 5-County Coastal Cooperative consistent with the State-s 9-1-1 initiatives
 - This partnership will establish resiliency (back-up 9-1-1 Services) as well as operational and cost efficiencies.

Part 1 Proposed Change to 9-1-1 Legislation

Title 23 – Law Enforcement and Public Safety Chapter 47 – Public Safety Communications Center



Fiscal Impact of Legislation

- No increase to 9-1-1 fees or taxes
- Not passing this legislation will eventually reduce the amount of reimbursements from the State 9-1-1 Fund



Legislation Revision History

Last revision

- Proposed April 27, 2010
- Effective July 1, 2011
- Added legislation to collect 911 fees
 - On prepaid wireless devices at point of sale
 - On voice over internet protocol (VoIP) communication services
- Did not address Next Generation 9-1-1 (NG9-1-1) needs



NG9-1-1

 Nationwide initiative aimed at updating the 9-1-1 service infrastructure to improve public emergency communications services in a growing wireless mobile society


- Text to 9-1-1 (we have an interim solution)
- Images via Text (we have an interim solution)
- Videos via Text
- Access to other data sources
 - Smart911 (we have a standalone solution)
 - OnStar
- Emergency call routing

ESINET (communications pipe)

 Communications network to transport the voice and data from the user to the 9-1-1 Center







Core Services (the brain)

- Intelligent processor that determines the 9-1-1 Center that should receive the call
- If this 9-1-1 Center is not available, it re-routes call to designated backup Center
- Sends Text, Images & Video
- Processes other data sources



General Purpose of Proposed Change

- Allows the South Carolina 9-1-1 Office to purchase and maintain an NG9-1-1 system that connects all of South Carolina.
 - The current legislation does not allow the State to purchase on behalf of the 9-1-1 Centers. The Counties must first purchase and then seek reimbursement.



Executive Overview of Proposed Changes

- Allow the State 9-1-1 Office to purchase NG911 Technology
 - Connecting all the 9-1-1 Centers in the state
 - Expanding capabilities for enhanced emergency communications:
 - Text, images, video and other data sent over IP networks
- Provide for a State managed ESInet & Core Services
 - Simplifies the NG911 transition for all, particularly the smaller counties/agencies
 - Increased resiliency and redundancy of 9-1-1 Centers
 - Standardizing 9-1-1 infrastructure in SC
- Improve operational and cost efficiencies while not increasing fees or taxes
- Provides an "and/or" clause so that the SCCJA can train and certify or simply certify those trained through an approved SCCJA curriculum



Critical Need

- Unlike current legislation, the proposed 9-1-1 legislation facilitates efficient transition to NG911.
- South Carolina's aging 9-1-1 wireline telephone system is fast approaching end-of-life.
- It is predicted that all 9-1-1 calls will come through IP networks as early as 2020.
- Many South Carolina 9-1-1 Centers do not support:
 - 9-1-1 applications in use now (i.e., Text To 9-1-1)
 - Basic transmission of information that allows jurisdictions to assist each other



Charleston County Benefits

- Better Service for our Citizens and our Response Agencies
- "Bulk Purchase" will result in overall cost savings = more 9-1-1 funds available for reimbursement
- Cost savings on connection costs
 - Connection Costs to other 9-1-1 Centers will be paid by State
 - Core Services Annual Costs will be reduced if using the State Core Services



Overall State NG9-1-1 Plan

- Introduce proposed Legislation and issue RFP in January 2019
 RFP award will be based on Legislation passing
- Contract for a statewide ESInet, Core Services and the maintenance of the system
 - Vendor(s) would be available on a state contract
- Counties could connect directly to the State ESInet or create regional ESInets that would connect to the State ESInet
 - Benefit to regional ESInets are redundancy and governance
 - Costs would only be reimbursed at the state contract price
- Respect "home rule" and County's Authority

Fiscal Impact of the Cooperative

- No negative impact
- May see positive impact due to cooperative purchasing
- All Charleston County funds expended will be from Charleston County 9-1-1 Funds
- At least 80% of those expenditures are eligible for reimbursement from the State 9-1-1 Fund

• Create partnerships through a shared regional NG9-1-1 System to provide better service and cost efficiencies.

Cooperative Status


- RFP review and input in progress
- Governance review and input in progress
- Charleston County Issues RFP Late January to early February
- Cooperative participates in the RFP review
- Charleston County awards and contracts with selected vendor
- Cooperative partners purchase off the Charleston County award and develop their individual contract with the selected vendor



Why are some coastal counties not listed?

- Any other County may purchase off the award
- Founding members already involved will comprise Executive Strategic Steering Committee for Cooperative.
 - Fewer Counties involved at the onset allows for a streamlined and efficient process, which is essential to meet our needs
 - Fewer Counties immediately involved will allow for more effective expansion of regional cooperative to other counties in near future .







Cooperative Goals

• Provide 9-1-1 backup in the event of disaster or overflow

- One agency provides service for another agency
- One agency physically moves into available space at another agency in order to operate during a disaster
- Beyond 9-1-1
 - Computer Aided Dispatch (CAD)
 - Radio
 - Operational Procedures



Our Cooperative and State 9-1-1

- State 9-1-1 participates with our Cooperative
 - Is aware, involved and supportive
- Our initiative
 - Is in alignment with State 9-1-1 Plan
 - Is a backup plan to receive Federal Grant money if our Legislation does not pass
