The Economic Development Department was approached by R&B of Charleston, Inc., the building owner and landlord for Cubby, Inc. (dba Holy City Linen) requesting to be added to the 2020 Fee-In-Lieu-of-Tax (FILOT) agreement, between Charleston County and Cubby, Inc., as a sponsor affiliate in order to be entitled to the same benefits of the agreement.

The Economic Development Director pledged, pending Council approval, to add R&B of Charleston, Inc. as a sponsor affiliate to the 2020 Cubby, Inc. FILOT agreement, providing to it the existing deal terms of a 6% assessment ratio and millage rate of 308.0 over the 20-yr. project term.

#### Situation:

On June 6, 2017 Council authorized the award of contract for engineering design & permitting services for Airport Connector Road to the most qualified offeror and allowed staff to enter into a contract paid for by funds from the 2013 Special Revenue Bond. As a part of this effort, Charleston County identified and received approval from the lead permitting agencies to proceed with the early acquisition of 11 parcels, including the 8 parcels on Lawyers Lane.



#### Situation:

In February 2022, County Council approved staff moving forward with the concept of a Tri-County Biological Science Lab in Charleston County via Council Directive 22-25. As a result, in October 2022 County Council approved both the award of a Design/Construction contract for the development of a new Tri-County Biological Sciences Lab and the acceptance of funding in support of the Development from both Berkeley and Dorchester Counties.

The County currently owns approximately 1.9 acres of land with improvements located at 3765 Leeds Avenue further identified by TMS# 412-00-00-012. The South Carolina Department of Corrections currently owns approximately 3 acres of land with improvements, also located at 3765 Leeds Avenue, further identified by TMS# 412-00-00-013, which is adjacent to the County's property. ("Property")

3765 Leeds Avenue is located at the corner of Leeds Avenue and Brickyard Creek Road, which is in close proximity to the Al Cannon Detention Center, the Charleston County Juvenile Detention Center, the Charleston County Sheriff's Office, and the Charleston County Coroner's Office. See the attached location map.

The South Carolina Department of Corrections is agreeable to sell their property located at 3765 Leeds Avenue to the County, further identified by TMS# 412-00-00-013 for the current

appraised value of One Million Two Hundred Seventy-Five Thousand Dollars (\$1,275,000.00) as of January 2023.

The acquisition of 3765 Leeds Ave offers centralized location benefits to Charleston, Berkeley, and Dorchester Counties and allows the County to combine the Property with the current County owned site at 3765 Leeds Ave creating a contiguous 4.9-acre site for the development of the Tri-County Biological Sciences Lab.

#### **Department Head Recommendation:**

Authorize the purchase of 3765 Leeds Ave, North Charleston, South Carolina, TMS 411-00-00-013 for the purchase price of \$1,275,000.00.

#### Situation:

On August 18, 2022, Council approved the set aside of \$850,0000.00 for community data and mapping to ensure that resources are being allocated properly across the County. After consulting with several organizations across the county, it was determined that there was only one agency that offered a collaborative approach to gathering the information that was needed to move Charleston County forward in its quest to ensure resources are being used in the most efficient and equitable manner.

Tri-County Cradle to Career Collaborative is a partnership between Tri-County Cradle to Career (TCCC) and DataNgine Consulting, LLC. The goal of this collaborative is to link resiliency to organizational capacity and help clear roadblocks created by the following issues related to data: access, usability, timeliness, and geographic specificity. They propose the following: TCCC proposes to harmonize Charleston County's administrative data sources related to the type of housing, quality of housing, and housing insecurity with publicly available data that will serve as the basis for asset maps that enable county staff to think tactically and strategically about partnerships and resourcing community services.

To enhance the value of asset mapping TCCC will develop and routinely update a set of asset maps. These maps will clearly show the relationships between specific neighborhoods, schools,

and the local environment. They will identify the locations of specific types of entities and services, such as grocery stores, bus stops, social service activities, etc., allowing the county to see gaps in services in underserved communities.

TCCC will provide technical assistance for community services planning, implementation and evaluation. Technical assistance will be provided in two forms.

1. Structured technical assistance for county staff aimed at on-going planning, implementation tied directly to data sources. This will provide information needed for the County's Comprehensive Plan as well as the HUD 5-year Consolidated Plan.

2. Structured technical assistance for tax-exempt organizations that serve as partners with Community Development working with the residents of Charleston County. According to TCCC, in 2022 seventy-two non-profit organizations had their tax-exempt status revoked, this number is reflective of each year since 2015.

TCCC's proposal coincides with - and amplifies - the launch of the Tri-County Data Collaborative, a TCCC initiative focused exposing local tax-exempt organizations to publicly available data sources, open-source software, and how to use both to improve local outcomes across the cradle-to-career continuum. Central to the Collaborative's operation is the idea that the only logical way to produce large scale changes in such indicators as kindergarten readiness, early grade reading scores, middle grade math scores, high school graduation, postsecondary enrollment, post-secondary completion and employment, is if tax-exempt organizations have the necessary capacity to focus resources on those indicators and work collectively to change based on a shared understanding of those indicators, including how different sectors impact each. According to TCCC, this is a completely unique approach to doing collective impact work because it operationalizes the concept of shared measurement, reduced work that is duplicative, and ensures that scarce resources are directed at the right populations in the right places at the right time.

The James Island Public Service District, South Carolina (the "*District*") was created and established as a special purpose district, a body politic and corporate, pursuant to the provisions of Act No. 498 of the Acts and Joint Resolutions of the General Assembly of the State of South Carolina for the year 1961, as amended. The District is located wholly within Charleston County, South Carolina (the "*County*"), and was established for the purpose of providing fire, solid waste, and sewer services within its boundaries.

2. In carrying out its functions and duties and pursuant to a resolution adopted on April 24, 2023, the James Island Public Service District Commission, as the governing body of the District, has determined, that a need exists to meet the capital needs of the District through the acquisition, design, equipping, improvement, rehabilitation and construction of Fire Station #2 in furtherance of the public safety operations of the District (the "*Project*"). The Commission estimates that the costs of the Project, together with the costs of issuance of the bonds described herein, will not exceed \$6,500,000.

3. In order to defray the costs of the Project, the District proposes to issue general obligation bonds of the District in a principal amount not exceeding \$6,500,000, which bonds may be issued as a single issue or from time to time as several separate issues as the Commission may determine.

4. The Charleston County Council (the "*County Council*"), the governing body of the County, is empowered by Sections 6-11-810 through 6-11-1050, inclusive, of the Code of Laws of South Carolina 1976, as amended (the "*Enabling Act*"), to authorize the issuance of general obligation bonds by the District pursuant to the provisions of the Enabling Act. Inasmuch as the principal amount of the bonds to be issued by the District at any one time and in one or more series does not exceed the general obligation bond debt limit of the District, as established pursuant to Article X, Section 14(7) of the South Carolina Constitution, it is requested that such bonds may be issued without approval of a referendum.

5. Pursuant to Section 6-11-830 of the Enabling Act, if the County Council, upon petition of the Commission, determines that it may be in the best interest of the District to raise moneys for the furtherance of any power or function of the District, the County Council may order a public hearing to be held upon the question of the issuance of general obligation bonds of the District.

On the basis of the foregoing, the Commission respectfully requests that the County Council order: (i) a public hearing to be held on the question of authorizing the issuance of an amount not exceeding \$6,500,000 of general obligation bonds of the District, (ii) approve such issuance by ordinance without the requirement for an approval referendum; and (iii) authorize the general obligation bonds to be issued as a single issue or from time to time as several separate issues as the Commission, in its discretion and within the constraints of Article X, Section 14(7) of the South Carolina Constitution, may determine.

#### A RESOLUTION NO. 23-03 REQUESTING THE INCURRENCE OF GENERAL OBLIGATION DEBT IN AN AMOUNT NOT EXCEEDING \$6,500,000; AUTHORIZING A PETITION TO THE COUNTY COUNCIL OF CHARLESTON COUNTY PURSUANT TO SECTION 6-11-830 OF THE CODE OF LAWS OF SOUTH CAROLINA 1976, AS AMENDED; MAKING AN OFFICIAL DECLARATION OF REIMBURSEMENT; AND OTHER MATTERS RELATED THERETO

**BE IT RESOLVED** by the James Island Public Service District Commission (the "Commission"), in meeting duly assembled:

#### ARTICLE 1 - FINDINGS OF FACT

#### Section 1.01

Incident to the adoption of this resolution (this "*Resolution*"), the Commission, the governing body of the James Island Public Service District, South Carolina (the "*District*"), makes the following findings of fact:

1. The District was created and established as a special purpose district, a body politic and corporate, pursuant to the provisions of Act No. 498 of the Acts and Joint Resolutions of the General Assembly of the State of South Carolina for the year 1961, as amended. The District is located wholly within Charleston County, South Carolina (the "County"), and was established for the purpose of providing fire, solid waste, and sewer services within its boundaries.

2. In carrying out its functions and duties, the Commission has determined that a need exists to meet the capital needs of the District through the acquisition, design, equipping, improvement, rehabilitation and construction of Fire Station #2 in furtherance of the public safety operations of the District (the "*Project*"). The Commission estimates that the costs of the Project, together with the costs of issuance of the bonds described herein, will not exceed \$6,500,000.

3. The County Council of Charleston County, South Carolina (the "County Council"), as the governing body of the County, is empowered by Sections 6-11-810 through 6-11-1050, inclusive, of the Code of Laws of South Carolina 1976, as amended (the "Enabling Act"), to authorize the governing body of any special purpose district to issue general obligation bonds whose proceeds shall be used in furtherance of any power or function committed to such special purpose district and in effect on March 7, 1973.

4. Pursuant to Section 6-11-830 of the Enabling Act, the County Council, upon petition of the Commission, may determine that it is in the interest of the District to raise moneys for the furtherance of any power or function of the District and order a public hearing to be held upon the question of the issuance of general obligation bonds of the District.

5. In order to finance the costs of the Project, the Commission has determined that it is necessary to issue an amount not exceeding \$6,500,000 of general obligation bonds of the

District to be issued either as a single issue or as several, separate issues, and in such amount and at such times as may be determined at the time of issuance thereof by the Commission (the "Bonds"). The Commission adopts this Resolution to evidence the Commission's request for the issuance of the Bonds in an amount not exceeding \$6,500,000 to defray the costs of the Project and to authorize a petition to the County Council with regard to the issuance of the Bonds. The maximum principal amount of Bonds requested hereby and to be outstanding at any one time shall be issued within the debt limit of the District, as permitted in Article X, Section 14(7) of the South Carolina Constitution.

#### **ARTICLE II - SUBMISSION OF PETITION**

#### Section 2.01

A petition, in a form substantially similar to that form attached hereto as <u>Exhibit A</u>, shall be presented to the County Council in accordance with and for the purposes set forth in Section 6-11-830 of the Enabling Act. The District Manager of the District, acting on behalf of the Commission, is hereby authorized and directed to deliver the petition, or cause the petition to be delivered, to the County Council.

#### ARTICLE III - REIMBURSEMENT DECLARATION

#### Section 3.01

The District hereby declares its intention to reimburse itself for a portion of the costs of the Project with the proceeds of the Bonds. To that end, the Commission determines and declares as follows:

(a) no funds from any sources other than the Bonds are or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside by the District pursuant to the budget or financial policies of the District for the financing of the portion of the costs of acquisition, design, equipping, improvement, rehabilitation and construction of the Project to be funded with the Bonds;

(b) the District reasonably expects that all or a portion of the expenditures incurred for the Project and the issuance of the Bonds will be paid prior to the issuance of the Bonds;

(c) the District intends and reasonably expects to reimburse itself for all such expenditures paid by it with respect to the Project prior to the issuance of the Bonds from the proceeds of the Bonds, and such intention is consistent with the budgetary and financial circumstances of the District;

(d) all of the costs to be paid or reimbursed from the proceeds of the Bonds will be for costs incurred in connection with the issuance of the Bonds, or will, at the time of payment thereof, be properly chargeable to the capital account of the Project (or would be so chargeable with a proper election) under general federal income tax principles; and

(e) this Resolution shall constitute a declaration of official intent under United States Department of the Treasury Regulation Section 1.150-2.
