NO TANGLERS

LEAVE OUT ITEMS LIKE HOSES, CORDS, BELTS, CABLES, & HOLIDAY LIGHTS.



NO HAZARDOUS & MEDICAL WASTE

CALL 843-720-7111 FOR HAZARDOUS WASTE DROP-OFF LOCATIONS. CALL YOUR LOCAL PUBLIC HEALTH DEPARTMENT FOR MEDICAL DISPOSAL INFORMATION.



NO SCRAP METAL

TAKE MIXED METALS TO YOUR LOCAL CONVENIENCE CENTER.



NO FOOD WASTE

DISPOSE OF FOOD WASTE IN YOUR COMPOST BIN OR GARBAGE CAN.



NO PLASTIC BAGS & FILM

RETURN CLEAN, DRY PLASTIC BAGS, WRAPS, & PACKAGING TO A LOCAL RETAIL OR GROCERY STORE.



NO CONSTRUCTION DEBRIS

LEAVE OUT BUILDING MATERIALS LIKE INSULATION, WOOD, & CONCRETE.
