## CCSO investigating after James Island woman is injured

Wednesday, June 21, 2023

**NORTH CHARLESTON, S.C.** – Deputies from the Charleston County Sheriff's Office continue to investigate the circumstances that left a woman injured on a James Island road early Wednesday.

Deputies responded about 5:40 a.m. to a report of an injured person in the road on Woodland Shores Road near Riverland Drive. The woman, a Woodland Shores Road resident in her 30s, was taken to a hospital for treatment of serious injuries.

Investigators were still working Wednesday afternoon to determine the nature of her injuries. At this stage, CCSO's Traffic Services Unit is leading the investigation.

### UPDATE Tuesday, June 27, 2023

Deputies continue to seek information from the public to determine how a woman was badly injured last week on a James Island street.

The Charleston County Sheriff's Office responded to Woodland Shores Road near Riverland Drive about 5:40 a.m. June 21 after the victim, Jennifer Drummond, was found lying on the street near her home. She was taken to a hospital for treatment of serious injuries. She remains hospitalized.

Deputies' investigation included canvassing the area for evidence, examining the scene and speaking with area residents, but the circumstances leading to the woman's injuries remain unknown. Though deputies from CCSO's Traffic Services Unit are actively investigating, the nature of the incident is undetermined.

## **VICTIM: Jennifer Drummond**

Crime Stoppers of the Lowcountry and the Charleston County Sheriff's Office need your assistance with information surrounding an incident which left victim Jennifer Drummond seriously injured. On June 21<sup>st</sup>, 2023, at 5:40 AM, the victim was located on Woodland Shores Road suffering from traumatic injuries. She remains hospitalized in critical condition. Deputies are investigating to determine the exact nature of her injuries, which are suspicious.

### **UPDATE Friday, June 30, 2023**

The Charleston County Sheriff's Office seeks the public's help identifying vehicles seen traveling on a James Island road shortly before a woman was found badly injured in the community.

Surveillance video captured the images on Woodland Shores Road early on June 21. About 5:40 a.m., the victim, Jennifer Drummond, was found lying on the road. She was taken to a hospital for treatment of serious injuries.

Deputies from CCSO's Traffic Services Unit have been investigating to determine what led to Drummond's injuries. Part of their investigation involves determining whether a vehicle struck Drummond.

Three vehicles seen in surveillance images (see attached) have not yet been identified by investigators. Whether any of these vehicles was involved is unknown. The images taken by a camera near the incident location show:

- A vehicle, possibly a pickup, at approximately 5:09 a.m.
- A vehicle, possibly a sedan, at approximately 5:13 a.m.
- A vehicle, possibly an SUV, at approximately 5:19 a.m.
