**NARRATIVE**

(Kiawah Island) On the above date and time, CCSO deputies responded to the above address in reference to what was originally reported as a shooting. The caller reported that he shot his girlfriend, and he believed that she was diseased.

As deputies were responding, dispatch informed responders that the caller further reported that there were children in the house as well and that he was threatening to shoot himself. Dispatch was only able to provide the caller information as a male who stated his name was Travis.

Deputies then arrived on scene and approached the front of the residence, which they observed a silhouette of an individual through the second-floor window balcony. Deputies presented their weapons and ordered the individual to raise their hands, which then deputies observed two pairs of hands raise and observed two individuals and then possibly a third person seen through the window. Once the subjects appeared compliant, one deputy approached the front door while the other maintained visual contact with the subjects. The deputy met subject 1 at the front door, subject 1 was advised that law enforcement was called to the location due to someone possibly being shot. Subject 1 explained that she is a caretaker for the homeowner's parents while the homeowner is on vacation. She further explained that everyone was okay, and no one had been shot.

Deputies then cleared the residence and confirmed that no one had been injured or needed medical attention. It was determined by responding deputies that the call was a hoax. Deputies spoke to subject 2, and the homeowner's parents (subjects 3 and 4) who also reported that they were okay and that there was no incident that took place at the residence. Deputies then spoke to the homeowner (subject 5) via phone, which the homeowner was already aware of the hoax phone call, but deputies advised her that everyone at the residence was okay.

A card was left with the occupants with a case number provided and they were advised to call the Sheriff's Office if anything further occurred. The patrol Sergeant and Lieutenant responded to the scene and spoke with the occupants. The subjects were provided an opportunity to listen to the 911 call and did not recognize the voice.

I was advised by dispatch that they received a 911 call to the center stating the Complainant was on the phone with the Subject who just shot her daughter and will shoot herself.

I advised dispatch to hold off on sending multiple deputies or other resources as this is the second time a call similar to this has come into the 911 center within days.

I arrived on scene and observed nothing out of the ordinary to the front of the residence. I made contact with the Subject at the front door and advised her I was at her residence for another false call. I observed no signs of any shooting or disturbance inside the home and the Subject appeared to not be in distress.

She informed me that the Director of SLED was notified of the first incident and that she will have her security detail reach out to SLED.

I advised the subject that if we could be of any further assistance to contact the Sheriff's Office. I requested a case number and cleared the scene without incident.
